SPECIFICATIONS (PROJECT MANUAL)

1. COVER

A. Revise "Bid Date" as follows:

1. Change from "November 21, 2017" to "December 12, 2017".

2. ADVERTISEMENT FOR BIDS

A. Page AD – 1: Revise "Bid Date" as follows:

1. Change from "November 21, 2017" to "December 12, 2017".

3. BID FORM

A. Page B-1: Revise "Bid Date" as follows:

1. Change from "November 21, 2017" to "December 12, 2017".

4. NON-COLLUSION BIDDING CERTIFICATION

A. Page NCC-1: Revise "Bids Due Date" as follows:

1. Change from "November 21, 2017" to "December 12, 2017".

5. INSTRUCTIONS TO BIDDERS

A. Paragraph 12, Time of Completion; Revise to read as follows:

"12. Possession of that portion of the premises affected by the work under this contract shall be given to the contractor immediately upon execution of the contract. He shall begin work on the date specified therefore in a written notice from the Commissioner of Public Works, Parks & Streets and shall regularly proceed with the same. Construction must only occur in the off season. Construction to begin at the end of the 2018 Bisons baseball season and must be completed by April 01, 2019."

B. Paragraph 17, Discrepancies or Omissions: Add the following sentence to the end of the Paragraph:

"The Contract Documents show approximate numbers of seats to be demolished and replaced. Contractor is to add the individual section numbers to attain approximate numbers. Do not use totals shown in general notes."

- C. Paragraph 19, Bidders to Visit Site: Add the following sentence to the end of the Paragraph:
"A mandatory walk through is scheduled for Tuesday, November 21, 2017 at 11:00 A.M. Meet at the loading dock."
- D. Paragraph 25, Award of Contract: Add the following paragraph to the beginning of the section:
"25. Basis of bid will be the base drawings plus a combination of alternates to be determined by the City after bids are received, based on the project budget."

6. SECTION 126300 – STADIUM AND ARENA SEATING

- A. Article 1.3: Remove Paragraph "F." in its entirety. Refer to 126300 – 1.8 for warranty requirements.
- B. Article 1.8, Paragraph "A.": Remove the word "standard" in the first sentence.

CLARIFICATIONS

- 1. M/WBE must be certified by the County and the City of Buffalo committee. Every M/WBE must have insurances required by the Project Manual and a City of Buffalo license (ex. electrician, light commercial contractor, etc.).
- 2. Bidders are to contact the City of Buffalo Office of Compliance to ensure the minority requirements of the Contract Documents are being met prior to bid.
