

**THE FOLLOWING STREETS DO HAVE A BUS ON THEM BUT WE DO NOT ENFORCE THE BUS ROUTE RESTRICTION NOV. 15<sup>TH</sup> – APRIL 1<sup>ST</sup> AS PER CITY ORDINANCE:**

**SECTION 15**

**(45) PARKING REGULATED ON BUS ROUTES, CERTAIN HOURS,**

Notwithstanding any other provision of the ordinances of the City of Buffalo, it is hereby Declared to be unlawful for any person to park any vehicle on any portion of any street on Which passenger buses are legally operated, or permit any vehicle under his control to Remain parked thereon for a longer time than necessary to load or unload passengers or Property during any period from 1:30 a.m. until 7:00 a.m. on any day between November Fifteenth (15) and April First (1) with the following exceptions and conditions on the Streets hereinafter mentioned in paragraphs 1,2,3, and 4.

1. **BUS ROUTES WITH NO DAYTIME PARKING RESTRICTIONS.** (Bus route in one direction only) On the streets listed below, parking shall be allowed at all times on one side of the street. On the opposite side, parking shall be prohibited from 1:30 AM to 7:00 AM.

**Hamburg St. between Perry St. and Republic St. (ODD)**

**Esperar St. between Efner St. and Trenton Ave. (ODD)**

2. **BUS ROUTE WITH A FULL TIME PARKING RESTRICTION ON ONE SIDE.** On the streets listed below, parking shall be prohibited at all times on one side of the street. On the opposite side, parking shall be allowed at all time.

**East Amherst St. between Parkridge Avenue and Bailey Ave. (ODD)**

**West Delavan Ave. between Niagara St. & Herkimer St. (ODD)**

**Hager St. between Northland Ave. and East Delavan Ave. (ODD)**
